## Short Sale ... Auction ... Foreclosure ... REO ... What does it mean?

The number of short sales and foreclosures has risen significantly in the past several months, states Rick Vague. There are growing numbers of homes available in this area that fall into the following categories:

**Foreclosure:** When a notice of default has been filed in the public records. The owner has stopped making payments and the lender has given notice that unless the payments are brought up to date, it will sell the property at auction to the highest bidder. During this time, the owner has the right to bring the loan current, if possible, and stop the auction.

**Short Sale:** A home is in foreclosure, but before the home goes to auction. The asking prices for these homes are less than market value, and less than the sellers owe to the lenders for the properties. Short sales have to be acceptable to the lender, but often these properties go on to be auctioned, because the lenders are not willing to take less than the amount they think they can reasonably get if the property is offered as an REO.

**REO:** Bank-owned properties are called REO's (Real Estate Owned). Banks end up owning a property when nobody at the public auction bids enough to cover the amount owed against the property. These REO's are then listed on MLS at discounted prices.

**Currently, there are just as many homes for sale in this area that are classified as "short sales" and REO's as there are regular homes for sale.**

## New Wood Burning Regulation

The Bay Area Quality Management District recently adopted a new regulation prohibiting wood burning on days when air quality is forecast to be unhealthy. Between November and February, when air quality is determined to be unhealthy, the Air District will declare a Winter Spare the Air Alert, during which time the use of wood-burning devices—including fireplaces, pellet stoves, wood stoves and fire pits—is illegal. People that burn wood as their sole source of heat are exempt from the

First-time violators will receive a warning letter from the Air District with information about the new rule and how to comply with it. Subsequent violations could result in fines from several hundred to several thousands of dollars, depending on the severity of the infraction. Wood smoke contains fine particles that can easily bypass the natural filters in the nose and penetrate deep into the lungs. Health studies have linked long-term exposure with serious health ef-

fects like aggravated asthma, chronic bronchitis and even premature death in people with heart and lung disease. On winter evenings, air cools and sinks close to the ground, while warm air acts as a lid over the cold air. When there is no wind to disperse smoke from fireplaces, it becomes trapped and can build up to unhealthy levels, affecting the entire community.
