#### c. Status of Collection Accounts

- i. Case 201603 Homeowner owes ASAP Collection Agency. There is no money owed to the Association.
- ii. Case 201801 No information from UTS. Will ask to move forward with forced sale. Learned that owners have passed away and that the daughter just discovered the lien on the property. Directed her agent to UTS. Agent is not sure if the daughter will sell or move into the property permanently.
- iii. Case 201802 –UTS is moving forward with forced sale paperwork; LPHOA was paid \$245 in fees in July. Contacted UTS this week and no payments have been made by owner. UTS contacted the owner about setting up a payment plan, however, there was no response. They will try again next week.

### 7) Old Business

- a. Pool refurbishment: Board toured the construction site, progress is good so far. Need to rebury electrical lines so that they are within current code as they were very shallow and prone to damage. Two skimmers will need to be repaired. Because of dry rot, the gazebo next to the baby pool will need to be removed, and replaced in the future.
- b. In Executive Session at the last Board Meeting, the Board voted to approve Andres Alfaro, Director at Large, until the end of the year.

- a. Ballots will be delivered to front door of homes. Ballots are due back on October 31<sup>st</sup>. Election official will be Melinda Doutt.
- b. The Board approved having a Townhall Meeting in the Clubhouse on new development in Housing as it relates to new zoning laws sometime this year.
